#### 4. CC&R Committee

**Gary Beavers** 

- Responses to survey were in the 20s. Noted that that is a low response that may indicate a lack of appetite from the community to make any changes at this time.
- Summary of those who did respond: There is openness to some % of metal siding and color pallet adoptions.
- Also, saw a desire add accountability in the form of fine structure.
- Next steps: Gary B. will type up a summary and show results including response rate so it can be shared with the POA. This can be further discussed after results are shared from the CC&R Committee.

#### **New Business**

- A short discussion about road work and that the work is out growing our budget. The hills are especially bad. It is likely time to investigate what is truly needed to fix the hills and all roads.
  - The board pointed out that the cost for such work has increased by double in some cases. If we are going to do anymore than bandaid our roads, we are going to have to have a realistic conversation about money. This will be a bigger conversation and to have that, we need quotes on what is needed.
