- Culvert on the Front Pond Update- Completed the installation of the culvert, still need to do some remaining tractor work and add larger rocks on top of loose gravel.

- Light on Crossbow Sign- Wallace Electric completed the install of LED lighting on the Crossbow sign at the gate.

- Corn feeder was moved from Stand 9 to 21 and Stand 1 to 3.
